# **PURPOSE**

This policy will provide clear guidelines for:

• how services comply with the Free Kinder funding requirements.



# **POLICY STATEMENT**

#### **VALUES**

Canterbury Gardens Kindergarten is committed to:

- supporting the Victorian Government's Free Kinder initiative
- increasing access to quality kindergarten programs for all Victorian children
- ensuring there are no financial barriers for families wishing to access an early childhood program for their child/children
- maintaining confidentiality in relation to the financial circumstances of parents/guardians.

# **SCOPE**

This policy applies to the approved provider, persons with management or control, nominated supervisor, persons in day-to-day charge, early childhood teachers, educators, staff, parents/guardians attending Canterbury Gardens Kindergarten.

# **BACKGROUND AND LEGISLATION**



# **BACKGROUND**

The Best Start, Best Life reform will help all Victorian children dream even bigger through increased access to quality early childhood education and care. A critical part of the reform is Free Kinder, which will support access to two years of high-quality kindergarten programs for all Victorian children. All families with a child enrolled in a funded kindergarten program are eligible for Free Kinder this includes both 3 and 4-year-old kindergarten programs.

Free Kinder supports families to access a funded kindergarten program by:

- providing a free 15-hour program to four-year-old children enrolled at a sessional service
- providing a free 5-to-15-hour program to three-year-old children enrolled at a sessional service (subject to the length of funded program offered)
- offsetting the funded kindergarten program component of parent fees for three and fouryear-old children enrolled at a long day care service

Free kinder supports every Victorian child to get the best start in life no matter where they live. Research shows that play-based learning is a powerful way to support children's learning and development. Two years of early learning is a crucial part of their educational journey, these benefits last into the school years and beyond.

Regulation 168(2) (n) of the Education and Care Services National Regulations 2011 requires that funded services have a comprehensive written fees policy, and the content of this policy must be



communicated to families. Any voluntary parent donations and/or fundraising must comply with the Free Kinder subsidy guidelines and be responsive to the local community.

#### **DEFINITIONS**

The terms defined in this section relate specifically to this policy. For regularly used terms e.g. Approved provider, Nominated supervisor, Notifiable complaints, Serious incidents, Duty of care, etc. refer to the Definitions file of the PolicyWorks catalogue.

**Additional Hours:** care that is provided by a kindergarten service to kindergarten children outside of the 15 hours per week program. *(refer to Definitions).* 

Early Start Kindergarten (ESK): A funding program that provides eligible children 15 hours of free or low cost kindergarten program each week for two years before starting school. To be eligible a child must by 3 by 30 April in the year they start kindergarten and be from a refugee or asylum seeker background, or identify as Aboriginal or Torres Strait Islander, or the family has had contact with child protection. Details are available at: <a href="https://www.vic.gov.au/early-start-kindergarten">www.vic.gov.au/early-start-kindergarten</a> If a child is eligible for ESK, they should be enrolled in ESK, even where Free Kinder and/or 15 hours per week of funded three-year old kindergarten is offered. This ensures eligible children have priority access to 15 hours of funded kindergarten provided by an early childhood teacher and that service providers receive additional funding and support. ESK enrolments contribute to School Readiness Funding (SRF) calculations for service providers. It also allows the Department to continue to monitor efforts to engage the most vulnerable children in kindergarten across Victoria and provide additional targeted support where required through SRF or Early Childhood LOOKOUT.

**Waitlist fee:** A fee for when families register their child directly with a service (not part the councils central enrolment scheme). This fee will not be refunded as it is not part of the Free Kinder subsidy, and not related to the fee charged for delivery of the kindergarten program.

**Excursion/service event charge:** An additional charge required to meet the cost of special events or excursions that occur in response to emerging children's program needs. Events that are planned ahead and are included as an expenditure item in the service's budget do not incur this additional charge (refer to Excursions and Service Events Policy)

Fees: A charge for program hours over and above the 15 funded hours per week (600 per year)

**Free Kinder:** A Victorian Government Best Start, Best Life initiative providing Free Kinder programs for four-year-old and three-year-old children in funded services, that have opted into the initiative.

Free Kinder supports families to access a funded kindergarten program by:



- providing a free 15-hour program to 4-year-old children enrolled at a sessional service
- providing a free 5 to 15-hour program to 3-year old children enrolled at a sessional service (subject to the length of funded program offered)
- offsetting the funded kindergarten program component of parent fees for 3 and 4-year-old children enrolled at a long day care service.

**Funded Kindergarten:** For service's that have not opted for Free Kinder, the Victorian Government provides funding to support children to access a high-quality kindergarten program in the two years before they start school. The funding is a contribution towards meeting the cost of the kindergarten program. Funded kindergartens charge fees to help meet the cost of running kindergarten programs. Fees are set by individual kindergartens and depend on things like how many hours children attend and whether there are extra costs such as excursions.

**Enrolment deposit:** A charge to secure a place that has been offered in a program at the service. This should not act as a barrier to enrolling for any families. Services must ensure that families understand that the enrolment deposits will only be refunded if the child commences in the service.

**Pre-Prep:** Four-Year-Old Kindergarten will gradually transition to Pre-Prep over the next decade from 2025. Funded kindergarten hours will double from 15 to up to 30 hours a week. Pre-Prep will be delivered through sessional kindergartens and long-day-care centres. By 2036, children across Victoria will have access to 1,800 hours of funded kindergarten before school, comprising 600 hours of Three-Year-Old Kindergarten and 1,200 hours of Pre-Prep.

**Voluntary parent/guardian payment/donation**: A voluntary payment/donation for items not directly related to the provision of the children's program. Explicit and written agreement from a parent is required for any voluntary payments. Attendance at the service is not conditional on this payment.

#### ATTACHMENT 1. FREE KINDER INFORMATION FOR FAMILIES

Canterbury Gardens Kindergarten 2026

#### 1. General information

Kindergarten programs for four-year-old and three-year-old children in Victorian Government funded services will be free as part of the Best Start, Best Life reform.

Free Kinder provides families with a free program in sessional services and a fee offset in long day care services.

DE also provides funding to assist eligible three-year-old Aboriginal and Torres Strait Islander children, Asylum seeker and refugee children and children known to Child Protection, to access kindergarten programs.

Refer to the Canterbury Gardens Kindergarten website for the program hours.

#### 2. What Free Kinder means at our service

Canterbury Gardens Kindergarten has opted in to the Free Kinder initiative. Applicable parent fees are outlined below:

- o Funded sessional kindergarten for 3-year-old children (up to 15 hours per week) no parent fee
- o Funded sessional kindergarten for 4-year-old children (15 hours per week) no parent fee

Canterbury Gardens Kindergarten will reimburse families in full for any kindergarten fee deposit (*refer to Definitions*) payments that have already been made upon acceptance of enrolment, excluding any voluntary parent donations/payments that you agree to in writing.

#### 3. Other charges

Other charges levied by Canterbury Gardens Kindergarten are included on the Statement of Fees and Charges, that will be provided to families upon enrolment.

These include:

Excursion/service event charge (outside of the 15 hours per week program): At times throughout the year an additional excursion(s) or event(s) may be arranged where it is considered relevant to the service's program and the children's interests. At this time, any additional costs to families are taken into consideration before a decision is made (refer to Excursions and Service Events Policy).

Late collection charge: The Committee of Management reserves the right to implement a late collection charge when parents/guardians are frequently late in collecting a child from the service. This charge will be set at a level determined by the Committee of Management.

# 4. Additional hours and/or wrap around care fees

Canterbury Gardens Kindergarten offers families 11 hours above the set 15 hours per week (600 hours per year) for the 4 year old program, and 2.25 hours above the set 15 hours per week for the 3 year old program. The additional hours fee is determined by the hourly program rate based on the scheduled fee (including the costs of regular incursions and excursions).

Families have the option of only enrolling for 15 hours and being charged no additional fees.

# 5. Fundraising and voluntary parent payment/donations

While **participation in fundraising/donation is voluntary**, the support of every family is encouraged. Fundraising activities are also an opportunity for families and communities to come together.

# 6. Payment of fees for additional hours

Fees are payable for hours over and above 15 hours per week (600 hours per year).

The Committee of Management will regularly review payment options and procedures to ensure that they are inclusive and sensitive to families' cultural and financial situations.



Fees will be invoiced to parents/guardians directly and must be paid by the date indicated on the invoice. Each invoice will be accompanied by payment instructions. The first term's fees must be received in full prior to the child commencing at the service. For children enrolled after the commencement of a term, a pro rata invoice will be issued and must be paid in full within 14 days of the child's commencement at the service. Receipts will be provided for all fee payments.

Parents/guardians experiencing difficulty in paying fees are requested to contact the Treasurer (treasurer@canterburygardenskindergarten.com.au) to arrange a suitable alternative payment plan. The *Privacy and Confidentiality Policy* of the service will be complied with at all times in relation to a family's financial/personal circumstances.

### 7. Unpaid fees for additional hours

If fees are not paid by the due date, the following steps will be taken.

- An initial reminder letter will be sent to parents/guardians with a specified payment date, and will include information on a range of support options available for the family.
- Where payment is still not received, families will be invited to attend a meeting to discuss the range of support options available and establish a payment plan.
- Failure to attend the meeting and continued non-payment may result in a second and final letter notifying parents/guardians that the child's place at the service may be withdrawn unless payment is made or a payment plan is entered into within a specified period of time. This letter will also include information on a range of support options available for the family.
- The Committee of Management will continue to offer support and will reserve the right to employ the services of a debt collector.
- If a decision is made to withdraw the child's place at the service, the parents/guardians will be provided with 14 days' notice in writing.
- No further enrolments of children from the parents/guardians will be accepted until all outstanding fees have been paid.

# 8. Refund of fees

The enrolment deposit (*refer to Definitions*) will be fully refunded to families only when the child commences at the service. Non-refundable waitlist fees (*refer to Definitions*) paid will be retained.

In any other case, additional hours are non-refundable (exceptional circumstances may apply – these are at the discretion of the Committee of Management. There will be no refund of these fees in the following circumstances:

- o a child's short-term illness
- public holidays
- o family holiday during operational times
- o closure of the service for one or more days when a qualified educator is absent, and a qualified reliever is not available
- o closure of the service for staff training days
- o closure of the service due to extreme and unavoidable circumstances.

In addition, there will be no refund where a family chooses not to send their child to the program for the maximum number of hours for which they are enrolled.

# 9. Support services

Families experiencing financial hardship often require access to family support services. Information on these services may be available from the kindergarten service provider or alternatively families may contact the local council.

# 10. Notification of fee changes during the year for additional hours

Fees set for the year would only be reviewed in extraordinary circumstances, for example, if attendance rates fall below the budget 'break even' point. Parents/guardians will be notified one term in advance of any required fee increase and will be offered the option to request a payment plan.

**Deposit:** Parents/guardians are required to pay the deposit on offer of a place. Payment is required by the due date to secure the child's place in the three-year-old kindergarten program. This payment is non-refundable until the child takes up the place at kindergarten. Deposits are refunded after commencement of the child at kindergarten.

**3-year-old gap fee**: Three-year-old kindergarten is fully funded up to 15 hours. The gap fee covers the additional hours offered as part of the Canterbury Gardens Kindergarten three-year-old program. Should you wish for your child not to take up the additional unfunded hours the daily core hours will be 9.30am – 2.30pm Monday, Wednesday and Thursday.

**4-year-old gap fee:** Four-year-old kindergarten is fully funded up to 15 hours. The gap fee covers the additional hours offered as part of the Canterbury Gardens Kindergarten four-year-old program. Should you wish for your child not to take up the additional unfunded hours the daily core hours will be 8.30am – 1.30pm Monday, Tuesday and Thursday.

**Payment of charges:** Invoices will be issued in the last month of the preceding term via email and must be paid by the due date. Please ensure your email address is current. Parents are welcome to pay the full amount upfront at the beginning of the year if they prefer.



**Parent Contribution:** Canterbury Gardens Kindergarten requests an annual parent contribution from families to compensate for the shortfall between the "Free Kinder" funding and the actual running costs of the kindergarten. This contribution is entirely voluntary. We ask for this contribution to allow us to continue to offer our current program whilst continuing to opt-in to the "Free Kinder" program.

**Children turning three during the year:** Full payment from the first day of term 1 is required if a place is to be reserved for a child in the three-year-old kindergarten program; however, children can only commence the program when they have turned three. Please note: children who have not yet turned three at the commencement of the kinder year are welcome and encouraged to attend the first day scheduled as orientation day.

**Late collection charge:** The Committee of Management reserves the right to implement a late collection charge when parents/guardians are frequently late in collecting a child.

**Concession Cards:** Exemptions are applied to the parent contributions for concession card holders. Please contact the Treasurer (<u>Treasurer@canterburygardenskinder.com.au</u>) for more details.

**Changes to Fees:** DET funding and VECTEA pay scales have not been confirmed for 2026. The Committee of Management reserves the right to change the fees if these are significantly outside of budget when posted.
